### INVITATION TO BID

### BID NO: SIYA 07/2023

**The Siyancuma Municipality invites prospective bidders to bid for the rehabilitation work at the Douglas: Water purification plant.**

The project entails the upgrading of the existing water purification plant. The main components, among other, are as follow:

- Replace existing raw water pumps at Oranje-Vaalrivier canal
- Build and install new electrical control panel
- Construction of 140m of 300 mm diameter uPVC supply pipe
- Construction of 11,51m diameter X 3,45m high round reservoir with roof
- Construction of concrete slabs for foundations of reservoir and filters.
- Construction of 40m, 300mm uPVC waste water pipe.
- Replace existing raw water pumps at Vaal river canal
- Construction of 1750m, 300mm class 9 uPVC supply pipe.
- Build and install new electrical control panel for Vaalriver canal pumps
- Supply and install purified water pump with control panel at existing purification plant.
- Supply and install flocculent and liquid chlorine dosing pumps at existing purification plant.
- Supply, construct and commission of UPMC-3 X 1800mm filters with electrical control panel and raw water supply pumps
- General repair work to existing buildings.

A **compulsory** site inspection shall be held on **10 May 2023, 11:00am** and prospective bidders are to meet the Engineers and the Client's Representatives at the Municipal Offices, 13 Charl Cilliers street in Douglas,8730.

Payment for the Bid document can be made at the pay offices of Siyancuma Municipality, Finance Department, Douglas, from 08h00 on 10 May 2023 upon **non-refundable fee of R1 500-00 (cash)** per document. Payment by cheque is not acceptable. Bid documents will be available at compulsory site meeting in Douglas, on submitting proof of payment.

BIDDERS SHALL TAKE NOTE OF THE FOLLOWING BID CONDITIONS:

- The Siyancuma Municipality Preferential Procurement Policy; Preferential Procurement Policy Framework Act (PPPFA) as amended and Municipal Finance Management Act will apply;
- The Siyancuma Municipality does not bind itself to accept the lowest bid or any other bid and reserves the right to accept the whole or part of the bid;
- Bids which are late, incomplete, unsigned or submitted by facsimile or electronically, will not be accepted;
- Bid's validity period will be taken as 120 days.
- All contractors including sub-contractors must be registered with the Construction Industry Development Board (CIDB).
- All contractors including sub-contractors must be registered on the National Treasury's Central Supplier Database to be considered eligible to tender successfully;
- Only contractors who can demonstrate that they will have in their employ staffs which satisfy EPWP requirements during the contract validity are eligible to submit tenders.
