**RFP for Four Laning of Kodinar to Veraval Section of NH-8E from km. 221.610 to km. 263.000 (design ch. From km. 222.400 to km. 263.180) (Package VI) in the state of Gujarat to be executed on Hybrid Annuity basis under NHDP Phase IV**

The Government of India had entrusted to the Authority the development, maintenance and management of National Highway No. 8E including the section from km 221.610 to km 263.000. The Authority had resolved to augment the existing road from km 221.610 to km 263.000 (design ch. from km. 222.400 to km. 263.180) on the Kodinar to Veraval section of National Highway No. 8E (hereinafter called the "NH-8E") in the State of Gujarat by Four-Laning thereof (the "Project") on design, build, operate and transfer (the "DBOT Annuity" or "Hybrid Annuity") basis, and has decided to carry out the bidding process for selection of a private entity as the Bidder to whom the Project may be awarded.
