RFP for "Four Laning of Una to Kodinar of NH-8E from Km. 180.478 to Km 221.610 (Design Chainage from Km 181.450 to Km 222.400) (Package-V) in the State of Gujarat on Hybrid Annuity Mode under NHDP Phase-IV".

The Government of India had entrusted to the Authority the development, maintenance and management of National Highway No. NH-8E including the section from Km. 180.478 to Km 221.610. The Authority had resolved to augment the existing road from Km. 180.478 to Km 221.610 (Design Chainage from Km 181.450 to Km 222.400) on the Una to Kodinar section of National Highway No. 8E (hereinafter called the "NH-8E") in the State of Gujarat by Four-Laning thereof (the "Project") on design, build, operate and transfer (the "DBOT Annuity" or "Hybrid Annuity") basis, and has decided to carry out the bidding process for selection of a private entity as the Bidder to whom the Project may be awarded. Brief particulars of the Project are as follows:
