**RFP for FOUR LANING OF TALAJA – MAHUVA SECTION OF NH – 8E FROM KM. 53.585 TO KM. 100.100 (DESIGN CHAINAGE FROM KM. 54.990 TO KM. 100.450) (PACKAGE – II) IN THE STATE OF GUJARAT on Hybrid Annuity mode under NHDP Phase IV.**

The Government of India had entrusted to the Authority the development, maintenance and management of National Highway No. NH-8E including the section from km 53.585 to km 100.100. The Authority had resolved to augment the existing road from km 53.585 to km 100.100 (design chainage from km 54.990 to km 100.450) on the Talaja-Mahuva section of National Highway No. 8E (hereinafter called the "NH-8E") in the State of Gujarat by Four-Laning thereof (the "Project") on design, build, operate and transfer (the "DBOT Annuity" or "Hybrid Annuity") basis, and has decided to carry out the bidding process for selection of a private entity as the Bidder to whom the Project may be awarded. Brief particulars of the Project are as follows:
