REQUEST FOR EXPRESSION OF INTEREST (EOI)
FROM PROSPECTIVE INVESTORS/ OPERATORS

1.0 INTRODUCTION

The National Automotive Design and Development Council ("NADDC" or "the Council") in collaboration with Infrastructure Concession Regulatory Commission ("ICRC") hereby request for expression of interest from prospective investors/operators towards the development, operation and management of a national automotive training centre of excellence.

2.0 PROJECT BRIEF

In furtherance of its mandate to develop a competitive Nigerian automotive industry, the Council seeks to deliver an automotive training centre of excellence ("the facility") under a Design, Finance, Build, Operate and Transfer (DFBOT) Public-Private Partnership (PPP) arrangement.

The facility which will be sited on a **5,430sqm** certificated land at the Jahi sector corridor, Federal Capital Territory (FCT), Abuja, will be recognised as a foremost industrial training facility in Nigeria. The facility will host major events such as automotive trainings, research, supports etc. Its design is expected to provide adjustments for other commercially viable complementary usages such as lettable office spaces, restaurant, hotel, event centre etc

3.0 OBJECTIVE

The proposed development upon completion aims to spur the growth of enterprises within automobile and other ancillary industries by bringing together customized automotive trainings, industrial capacity building programmes, research and social engagements in one precinct.

4.0 SUBMISSION OF EXPRESSION OF INTEREST

Prospective bidders are hereby invited to submit Expression of Interests (EOIs) detailing the following as bases for pre-qualification:

- Full Name and Nationalities (countries of registration of firms or consortia). Where bidders choose to submit EOIs in consortium, it must clearly indicate the overall lead firm. Consortium will be pre-qualified on the strength of members within the consortium.
- Overall contact person(s), email addresses, facsimile and telephone numbers

- Profile of firm or firms (if in a consortium); including ownership structure and role of each firm; with full contact details (including phone numbers and email addresses)
- Evidence of association or participation in the consortium
- Evidence of track record of successfully carrying-out the development and/or management of training facility, event centre or other related facilities
- Evidence of capability and previous experience in undertaking PPP projects or Joint Venture projects or Partnership projects
- Evidence of firm or consortium's registration; including Certificate of Incorporation or equivalent registration documents, copies of Memorandum and Article of Association and Form C07
- Evidence of Tax Clearance Certificate (TCC) and Returns to the Federal Inland Revenue Service (FIRS) for 2012, 2013 and 2014
- Most recent audited financial statements of firm or firms within the consortium (2013, 2014 and 2015)
- Evidence of available financing/access to credit lines to execute the development

Each Expression of Interest (EOI) should be submitted in six (6) copies in a sealed envelope clearly marked "**Expression of Interest – Development of Training Centre of Excellence**". The lead firm's name should be clearly printed on the reverse side of the envelope. A CD-ROM version should also be included.
